



## New posters for businesses to display to remind staff and customers of continuing covid actions

Now that the government has lifted all restrictions under step 4 of the roadmap, businesses are being reminded to remove any outdated covid-secure posters they may still have on display.

Updated workplace posters are available on the [coronavirus resource centre](#) to remind businesses and customers about the new workplace guidance and the behaviours that people should still adopt.

Businesses can continue to display QR posters so that customers can continue to check-in to support the NHS Test and Trace programme.



## Business Secretary launches new plans to put UK at front of global innovation race

Kwasi Kwarteng delivered a speech at the Advanced Manufacturing Research Centre to mark the launch of the Innovation Strategy on Thursday 22nd July, which you can [watch online](#). The strategy sets out plans to cement the UK's position as a world-leader in science, research and innovation and is a long-term plan to boost private sector investment across the UK and create the right conditions for all businesses to turn world-leading science into new products and services. ## New guidance on self-isolation published to protect key infrastructure

Businesses can now apply to exempt certain workers from NHS Test and Trace self-isolation rules under new guidance published last week.

The guidance is not intended to cover whole sectors or job roles, but instead allows businesses to name specific individuals whose absence could cause major disruption to critical services such as food supply, transport or energy.

Employers who believe that an individual should be exempt to prevent major disruption to critical services should apply to the relevant department. Contact details are set out in the guidance on [GOV.UK](#).

## New advice on travelling to and from the office

To assist businesses as they prepare for employees to return to workplaces, the Department for Transport has issued updated [guidance for passengers](#) in England on how people can travel safely.

Travellers are advised to plan ahead, regularly sanitise their hands and open a window where possible. Some operators require passengers to wear a face covering, and it's recommended that all passengers do so if they can. ♦

### **BEIS publishes new consultation on Reforming Competition and Consumer Policy**

Last week the department published its proposed reforms to boost competition and protect the public from being ripped off.

Proposals set out in the consultation include new powers for the Competition and Markets Authority to improve enforcement of consumer law and plans to tackle ♦subscriptions traps♦ and fake online reviews so that consumers can spend with more confidence.

The consultation also sets out new and enhanced powers for the competition regulator to help drive innovation, productivity and growth. Under the plans, the♦CMA♦will be able to wrap up investigations faster and impose stronger penalties on firms that break the law or fail to cooperate with the regulator♦s work.
